- o Supporting the overarching contract management process and help further develop and ensure compliance with EFL procurement policies where applicable.

- o Reviewing and communicating key terms from contractual and other legal documents to project owners across the business.
- o Assisting with the distribution, recording, filing, and archiving of fully executed contracts and amendments.
- o Assisting in the provision of general legal advice in other areas relevant to the business including football regulatory legal work, consumer legislation, and regulations relating to advertising and promotion.
